Control Systems



This course will focus on modeling of linear dynamic systems, Laplace transform techniques, linear feedback control systems, stability criteria, and design techniques.

Network Analysis



This interdisciplinary course introduces students to fundamental theories, concepts, methods and applications of network analysis. We will focus on social, socio-technical and information networks. Students learn how to approach network analysis in an informed, systemic and analytically rigorous

fashion. At the end of the course, students will be able to design, manage, and execute network analysis projects.



All classes will be in English. Certificates will be awarded upon successful completion.

The Courses

Development Economics

This course focuses on the application of economic reasoning and analysis to business decision-making. Topics may include demand and supply analysis, estimation of demand by firms, pricing and non-price competition in contested markets, gain theoretic perspectives on business strategy, and other topics of interest.

Money & Banking

This course will focus on the forces (information and transaction costs) that have propelled the historical evolution of money, credit, and financial intermediation from the ancient world to present. Related financial institutions such as bond, stock, and insurance markets are also explored. In addition, the course will cover the structure of the Federal Reserve System and bank regulation.


